Vice President's Report

As we finish the year's finish line, I'm sure that we all share the same/routine end-ofyear rush hour. We seem to go from 100 mph in April to nearly zero in May, very quickly.

District Fiscal Advisory Committee (DFAC):

The DFAC is a districtwide committee with broad representation. As the name implies, it's not a decision-making committee. But in my short tenure on the committee I realize that committee member input is valued concerning potential budget decisions at the district and Board levels.

The last meeting was on March 21st. A few interesting items to report are the Resource Allocation Model (RAM) and the Columbia College Housing plans.

The RAM was a continuing discussion item. This was brought to the Academic Senate in February, where feedback was sought. In essence, the RAM includes how the district and colleges' budgets will be reduced, if that becomes necessary. Note: there is no official plan to reduce the budgets at this time.

MJC, CC, and Central Services have uniform budgeting formulas in the RAM that would become the basis of budget reductions. In short, CC and Central Services budgets would be reduced before MJC, because MJC is considered unbudgeted. However, CC's budget cuts would not be greater than ½ of the budget that CC receives over the student-centered funding formula.

Also discussed was the future of CC's student housing. The housing was built by a 3rd party in 1984. The agreement between the vendor and YCCD was that the vendor pays for the construction and in return would have a 40-year lease. That 40-year lease is up this summer. So this summer the *keys will be handed over* to the district.

A need for financial planning concerns the facility's need to modernization. Particularly the long-term maintenance and repair needs, and also the ADA accessibility requirements. An "Immediate" and "Long Term" budgeting plan was presented to DFAC. The "Immediate" budget needs are \$642, 100. And the "Long Term" budgeting needs (11-20 years) are \$7,210.800.

Academic Senate President Elect:

It's time to start thinking of running for participatory governance positions for next year. I am selfishly interested in seeing a candidate(s) for the president-elect position (2025-2026 AY). Remember, the elections now take place early in the year (fall). I encourage everyone to consider this position. Best wishes to everyone and a successful end to the year!

Curriculum Chair Report

At the beginning of the year, the Curriculum Committee faced a daunting list of tasks related to operationalizing legislative mandates, assisting in the development of our submission of the Baccalaureate Degree Proposal for Cooperative Land Stewardship, as well as processing the first full cycle of the Sunset list. The 2023-2024 Sunset list has been processed and only a handful of courses will be administratively deactivated. This work was done with full transparency and with consultation between faculty and division deans.

Two things cause a course to be placed on the Sunset List.

- Curriculum past due for review (a faculty responsibility)
- Courses that have not been offered in a 2-year cycle (a discipline dean & faculty responsibility)

The Curriculum Committee has worked with division deans to publish a student facing 2-year course offering projection which will be available on our college website in July. Division deans have agreed to use this 2-year plan as they build the schedule each term. This should reduce the number of courses on the Sunset list each year. The Sunset List should not be the way we are managing curriculum. The five-year course review tracker should be utilized to maintain our curriculum and program review should guide curriculum development. This allows us to have meaningful conversations about where we are, where we want to be, and what is necessary to move forward.

The 2024-2025 draft Sunset List is being developed currently. When it is shared, **please don't panic**. You will have a full year to work on bringing your curriculum into compliance. While workflows in eLumen will be open in the Spring term for submissions, we strongly encourage you to do your curriculum planning in fall.

Curriculum is central to our work at Columbia and deserves focused attention and planning. I have proposed a staff development training and dean collaboration focus for In-Service and Flex Day this coming fall.

Curriculum prioritization is required next year to accommodate legislative mandates. Click on <u>proposed timeline and</u> <u>prioritization</u> to see the document that was approved at the last meeting Academic Senate meeting.

There is a Faculty Intern position open on the Curriculum Committee. This is a non-voting position and while it does not include compensation, it is an opportunity to learn about our curriculum process at Columbia College. Contact Stephanie Beaver-Guzman if you are interested.

Organizational stability at Columbia College comes from the faculty. Leadership at Columbia is ever changing. Please engage in our curriculum and program review processes, advocate for your programs and work with your division deans to chart a path forward. It has been my honor to serve the Curriculum Committee this year.


This spring, TLC has hosted a few Wellness Workshops in partnership with Marlyn Lieder and our mental health team that have been really well attended and received.

Institutional Effectiveness Committee, Finance Committee, and Cultural Enrichment Committee

Institutional Effectiveness Committee (IEC)

The IEC met twice since my last Academic Senate newsletter blurb. The final IEC meeting of the semester took place on 4/1. Effectiveness is increasing in a variety of areas!

- Program Planning and Evaluation (formerly known as Program Review) is moving ahead with 5 programs piloting the newly developed form. Stay tuned for process details and timelines for Program Planning and Review.
- The constituent group portion of the Participatory Governance Handbook was updated with feedback from the leaders of the groups in that section. A workgroup will develop proposed edits to the core of the document and present them to the IEC for the first meeting of the fall.
- The IEC is looking for a staff survey that encompasses the existing Governance Structure survey and collects more comprehensive information about campus climate and staff satisfaction. Matt brought a sample to the meeting to review but the group decided to keep looking for a survey that better fits our needs.
- The IEC reviewed the Cyclic Review Plan and moved plans that don't exist yet to a separate section of the plan. Adrienne will be working with College Council to propose changes to the cycle for affirming/revising mission, vision, and values statements.
- A workgroup will be proposing an IEC master calendar (what needs to take place each month) to the incoming Vice President of Instruction (VPI) when they arrive and the IEC in the fall.
- Enrollment Management conversations have been tabled until the new VPI is in place.
- The IEC is thinking about how to hold a "Dreaming with Data" day to support programs in using data to inform and realize their goals. The group also talked about changing the IEC meeting schedule.

Finance Committee

The Finance Committee has not met since 2/23. Those who submitted one-time funding requests have been contacted to inform them that their projects are funded. The April meeting was cancelled and has not been rescheduled.

Cultural Enrichment Committee

The Cultural Enrichment Committee (CEC) has some great stuff cooking for spring semester! The CEC is highlighting foster care experiences for the month of April and displays will be going up around campus. The group is working on reconnecting with our local tribes to envision how we can utilize the recreated Mi-Wuk cultural site on campus. The group was awarded \$25,000 in one-time funds to support its activities next year. Check out the <u>CEC website</u> for current events. Everyone is invited to the CEC meetings happening the last Wednesday of the month, 3-4 pm in Buckeye 104. Each meeting starts with a cultural ice breaker activity. Great ideas that can be used in classes or programs with students. Hope to see you there!

The Distance Education Committee will have the last meeting of the semester on April 19th. Below are items we've been working on and discussing during meetings.

- The committee is reviewing three documents, the DE Plan, DE Faculty Handbook, and Regular and Substantive Interaction Practice. We'll continue to revise these documents at our April meeting.
- The committee discussed the new Title 5 requirement to communicate technology requirements to students at the time of enrollment.
- With the OEI Proctoring Networking having been discontinued, we are working on finding alternative options for proctoring exams in online courses.
- A Spring-Summer 2024 cohort of Online Instruction Training began April 1st. Fall 2024 training is tentatively scheduled for August 30th-October 27th and Spring 2025 January 17th-March 16th
- Daniel Barsotti is the new Instructional Support Specialist for DE! Daniel has already created a new playlist of videos for students <u>Canvas Navigation Videos</u>. These videos are available on our <u>Online Learning webpage</u> under Learn to Navigate Canvas and Zoom! Please share with students!





Vice President's Report

Columbia College – a Unique Community College

As one of the 10 smallest community colleges in California, Columbia College offers an oasis for faculty in higher education. Of course, there are those who prefer the larger colleges with the big city shopping centers, et al. But it's safe to say that those of us fortunate enough to work at Columbia College value the small college setting in lieu of the larger crowds and urban surroundings. And I've always felt that we have one of the most beautiful campuses in the community college system.



Even our Academic Senate has its uniqueness, compared to larger colleges. The typical organization for a community college academic senate is to have representatives from each division serve as senators. And only senators vote in routine senate matters. At Columbia College, we are a Senate-of-the-Whole, which means that we are all senators with full voting rights. And as a smaller faculty, we tend to be more aware, and perhaps, more sensitive to our senate issues.

There is at least one downfall to having a smaller campus with fewer faculty. While each community college academic senate enjoys the *rights* of AB1725 shared governance, there is also an *obligation* of faculty to serve in shared governance roles. And arguably, whether a small college or large, there are relatively the same number of participatory governance positions to fill. Unlike larger colleges with a high number of faculty, we often "double up" in our shared governance appointments. And this problem is worsened when the 54 full-time faculty are not all participating in the needed roles. Bottom line, fewer faculty are filling the needed roles for the entire faculty. Putting aside our professional work week obligations (which includes participatory governance), it is unfair for faculty to not participate in participatory governance and, consequently, force the *other* faculty to fill more roles. I encourage all faculty to fill at least one shared governance position, big or small. It will make a world of difference to the mission of the academic senate and also to the workload of those faculty who have been consistently stepping up.

And for the newer faculty - there is a reasonable forgiveness factor for newer faculty's shared governance participation. We all know that time and effort spent on our new faculty positions are paramount. But after the first year our professional obligations dictate that we are all part of participatory governance – not to mention our contractual obligations to do so.

So how can we strengthen our influence as an academic senate? For one, the more faculty attendance at the monthly meetings, the more informed faculty become. And, the administration would recognize a more completely united faculty with increased attendance. Power in one!

There's also the resolution process. Both the state and local academic senates use the resolution process to either 1. publish an official position of the senate, and/or 2. to direct something to happen. Often, the *directing* involves the leadership doing something. Whatever the intent for the resolution, it's a powerful tool for the senate to publish and enforce its will, regarding the 10+1.

Resolutions can be authored by any faculty/senator, co-authored, or authored by the senate executive committee. The "Resolved" paragraphs state the senate's position(s) on the subject matter, and the "Therefore" paragraphs state that a certain position or action be taken. It's not complicated and it's an official voice of the senate-of-the whole.

Institutional Effectiveness Committee, Finance Committee, and Cultural Enrichment Committee



Institutional Effectiveness Committee (IEC)

The IEC met on 2/5 with a full agenda.

- Mike Igoe provided a report from the Diversity, Equity, Inclusion, and Access (DEIA) committee.
- Melissa Raby reminded the group that the accreditation team is reading the self-study and currently looking at evidence. The team will request additional information as needed. There will be an open forum with ACCJC on 3/6/24.
- Matt requested input on the Student Satisfaction Inventory Survey which is administered every 2 years. There are 10 questions that we can design locally. A small group met after the IEC meeting to create those questions.
- Matt shared the updated Participatory Governance Survey questions. The Council suggested that we add info about how the survey is used/how results are used. We only do 2 surveys as a College, the Student Satisfaction Survey (lengthy and detailed) and the Participatory Governance Survey which is short. The Council discussed creating a broader survey for faculty and staff with governance as one portion.
- Sean shared the challenges of conducting program review in areas where there is no full-time faculty. Matt shared an excellent Program Review Strengths Weaknesses Threats Opportunities (SWOT) analysis that he created. Despite the lack of a person in the VPI role, Adrienne shared that we need to do something with program review this year. The IEC directed Adrienne to bring the current Student Learning Outcomes Program Review Cycle (SLOPR) to the SLOPR committee to discuss what we can get going this semester. Adrienne agreed to rejoin the SLOPR committee to be a liaison between the two groups.
- The Council will work on a Participatory Governance Handbook Review Plan at the next meeting.

Finance Committee

The Finance Committee met on 2/23 to review One-Time Funding requests. All of the requests submitted were approved by the committee! The list will then move to College Council and finally to the President for approval. Thank you to Colin who has agreed to step in to serve on this committee for Dr. Beaver-Guzman who is currently on sabbatical.

- Kristina is working on creating a Finance Committee webpage.
- Jeremy Salazar YCCD Controller presented the Total Computational Review (TCR) for district revenue.
- Adrienne requested a clear accounting of the one-time funds (Fiscal Year (FY) 2022-2023 and FY 2023-2024.
- Adrienne also requested that the people who made requests receive clear information about the status of their requests as they move through approval and implementation.
- Adrienne proposes renaming these funds to a more appropriate name like College Annual Savings.

Cultural Enrichment Committee



Distance Education Committee


The Distance Education Committee has met twice this semester so far. Below are highlights discussed during these meetings.

- There is now a Columbia Online Teaching Tools Canvas resource shell. This shell is for Columbia Faculty and Canvas designers. It functions as a space to find guides, resources, and tools for teaching online.  - Join Columbia Online Teaching Tools
- Small workgroups have been meeting to develop recommended practices for facilitating Regular and Substantive Interaction (RSI) in online courses. This document is part of another project, which is updating the DE Faculty Handbook. Both workgroups have finalized a recommended document for the Committee that will be brought to the March meeting.
- A planned future workgroup will be developing a template "Start Here" module that anyone can adapt for their online courses.
- The Committee also met to review the updates to the DE Plan. Our February meeting was a working meeting in which everyone provided feedback on sections of the plan. We will revisit a revised version in March.
- Significant updates to the <u>Online Learning webpage</u> have taken place. The front page is full of student resources, and there have also been updates to the page on <u>Faculty Resources</u>.
- The committee has also been discussing recent updates to Title 5 that will require any technology requirements in an online course shared with students at the time of enrollment.
- A survey was sent out about upcoming workshop topics and tools we've been discussing as a committee. If you haven't completed that, please do! Your input is greatly appreciated! <u>Distance Education Survey</u>




Foundation Faculty Advisor

President Tran reported the hiring of a new position and the current positions posted as follows:

- Graphic Media Coordinator hired, pending board approval. Start date: 3/1/24
- Director of Career Planning (k16) and VPI posted for recruitment.

President Tran then announced an update on funding. Some highlights are as follows:

- Proposing to apply for a \$2 million grant to fund a fire tower.
- Applying for \$5 million to build out Columbia's nursing program.

Next, President Tran announced an update on safety at Columbia College as follows:

President Tran indicated that although our campus has security, we need certified officers present on campus. 

Vice President's Report

The Brown Act - Spring, 2024 and Forward

At our last Senate meeting we discussed the Brown Act and the Senate's requirement to hold meetings in person, beginning January 1st. I've since had some questions from faculty concerning these 'new' rules. So, here's a recap:

The "Classic" (pre-Covid) Brown Act provision allowed for remote teleconferencing. And because the Classic Brown Act still applies, "A" member can join the meeting remotely so long as 1. That remote location is published in the agenda, 2. The remote location is open for the public to join the meeting, and 3. That member does not join remotely for more than 20% of the meetings in a calendar year.

The only real change, starting in January, is one additional option: if "A" member wants to join remotely and has a justifiable reason (caring for a family member, sick, traveling on district business, etc.), that remote location need not be published in the agenda and that location need not be open to the public. While the Senate meetings will need to be scheduled for in-person, faculty may remotely join those meetings for up to 20% of the calendar meetings.

<u>VPI</u>

Our VPI office has experienced some irregularities in terms of having a VPI. As we know, Brian Sanders is currently our (permanent) VPI. However, he was assigned as MJC's interim VPI and he remains in that position today. To fill his spot, Raelene stepped up as our interim VPI. But Raelene is currently on leave. Dr. Tran chose to fill the VPI vacancy by assigning those tasks to Melissa Raby, as an additional duty. But that doesn't seem like a prudent move, IMO. The VPI on any campus is arguably one of the most important positions. The VPI ensures compliance with many Title V mandates, oversees enrollment management, serves as the district officer for our curriculum issues, and many more very vital tasks. VPI duties can't be effectively accomplished as additional duties.

Brian Sanders is a finalist for the president position at Woodland Community College and also MJC. If he becomes a president at one of those colleges, or does not get one of those positions and decides not to return to Columbia College, we need to work with administration to get the search going for a permanent VPI quickly!

Curriculum Chair Report

The Curriculum Committee continues to move forward with implementation and operationalization of multiple legislative modifications to California Educational Code. A big thanks to all the members of the Committee for their commitment to the well-being of the college's curriculum.

> The Academic Senate approved the Columbia College Philosophy and Criteria for Associate in Science and Associate in Arts Degrees and General Education at the November 17, 2023 Academic Senate meeting.
> o Area E will no longer be a part of CCGE



- In addition, our Noncredit Coursework and Certificates of Competency and Completion Requirements for the 2024-2025 Catalog were approved.
- Columbia College's guiding principles for Activity Units were also approved. Activity units at Columbia will be referred to as "Lab with Homework (Activity) Units".
- New courses were assigned to appropriate disciplines in the following areas: Ethnic Studies, Music, Geography and Guidance.
- Columbia's Baccalaureate Degree Proposal in Cooperative Land Stewardship was denied approval by the CCC Chancellors Office on 10/13/23 however, administration plans to resubmit in January.
- In Spring 2024 the Curriculum Committee will be reviewing curriculum developed by MJC faculty working on stipends resulting from a grant award related to Health Career Education. Administration informs us that we will be offering a Certified Nursing Assistant (CNA) Skills Attainment Certificate as well as a Medical Assistant (MA) Certificate of Achievement. Columbia College does not currently employ any qualified discipline faculty in Medical or Health Career Education which is why MJC faculty will develop the curriculum. Administration is going after grants in areas that we do not have fulltime faculty. Full-time faculty were not requested in the College Outlook.
- The Academic Senate approved waiving the Academic Senate bylaws to include all full-time faculty members as eligible to serve as Curriculum Chair for the 2024-2025 academic year.
- SLOPR Coordinator position on Curriculum Committee updated to SLO Coordinator to reflect changes to the SLO MOU .
- Title 5 (55250 et seq) has been updated with regards to Work Experience. This will require modification on all Work Experience classes in all disciplines. The Curriculum Committee is seeking to coordinate with administration on the appropriate course of action for these modifications and alignment with board policy.

Technology Committee

The Technology Committee met on November 16.

- Some Committee members have shifted since the last meeting in the spring; consequently, all participants were introduced. Brook Crouse, Executive Secretary of Student Services conducted the meeting.
- Jeff Swank reported on the issues with the Oak Pavilion sound system which was installed incorrectly, and now is being assessed and problem solved.
- Martin Kjaer led a discussion about charging students for nonreturn of laptops. Suggested fees would be \$150 for old laptops, \$450 for new ones, and an undisclosed amount for the high-end laptops.
- Martin encouraged anyone interested in replacing old computers for their department, to get a quote from our IT. Current money for replacement of computers will not be like it was during Covid. Purchasing computers will be a department-by-department decision pending available funding.
- Ryan Brady announced that New Firewalls have been installed across the District providing greater protection for the network. Eventually Columbia sill be getting new desk phones.
- A discussion about MFA (multifactor authentication) took place. All colleges that receive federal money, (like Pell Grants) are required to implement MFAs. There is currently the ability to sign up for MFA via the IT Service Portal for those who wish to participate in a soft roll out.
- Joe Macklin announced that they are now working on the CVC-OEI (California Virtual College-Online Educational Initiative) which will allow Columbia College to become a teaching college for Distance Education. That could occur sometime in the spring semester.



Vice President's Report

FHP Process

At the time of this writing we look forward to our FHP meeting on Friday, October 27th. We have all been asked to complete a survey that addresses each proposal, which will be compiled as a resource for this meeting. And at this meeting, we will build consensus as to the rankings of each proposal.

Then, a combined faculty-administration FHP committee will meet to finalize the rankings of the FHP proposals. *Note: the faculty consensus on the ranking may change, based on the discussions during this meeting.* Those rankings will then go to Dr. Tran, for her final determination on which faculty positions are to be filled.

Each year the district authorizes new and replacement positions that Columbia College can fill. Some years we are authorized no new faculty positions. It seems that an average of two or so positions are authorized. However, we've seen many more faculty positions authorized in recent years. Marcus and I met with Dr. Tran on Tuesday, October 24th and she confirmed that the district has not yet authorized new faculty positions. While I have not been involved in Senate leadership for a while, I don't believe that it is unusual for us not to have faculty positions authorized this early in the year. The district uses many metrics to make decisions on new and replacement faculty positions. And so FTES, retirements, and other data for this year may be needed to inform the district their authorizing faculty hiring. From my memory, it seems that late the fall, or early in the spring semester is a more common timeframe for the district to announce new faculty positions.

<u>50% Law</u>

As an FYI, the 50% Law refers to the requirement that all k-12 and community college districts must spend at least 50% of their budget for instruction. And specifically, *direct* instruction. What this boils down to is classroom teachers and classified staff positions that support that direct instruction. So, for examples, positions such as a counselor, administrator, or admissions and records specialist would not be considered direct instruction. The 50% Law is one of many considerations that the district uses to determine new or replacement faculty hiring.

These initiatives will require extensive planning and human resources to fully implement. The acting VPI agreed that we should begin planning for our Articulation officer to receive 100% release time beginning Spring 2024. As a point of clarification, Melissa Raby did not think we needed to take this through the Academic Senate as a resolution or MOU. She indicated that she would follow up as soon as possible to codify this plan. After sharing this information with Academic Senate leadership, it was decided that we would prepare a Resolution to codify the plan. You should expect to see a first reading at the November Academic Senate meeting.

3. Elections Curriculum Chair- Columbia College will need to secure a new Curriculum Chair for 2024-2026 academic years. Based on our current bylaws the following individuals are eligible to be the chair. Currently there is 50% release time for the Curriculum Chair. Discussions have begun with the Acting VPI regarding the appropriateness of this release time amount given the curriculum related initiatives. Additional information will be shared as it develops.

Institutional Effectiveness Committee (IEC)

The IEC met on 11/6 and discussed the results of the Governance Survey, the Educational Master Plan (EMP), and the Cyclic Review Process. Matt shared the participation on the governance survey was lower than the previous year and the group discussed how to increase participation in the future. The survey included three new questions. Matt will share the qualitative responses collected on the survey at a future IEC meeting.

The group approved the second reading of the EMP and sent it on its way to College Council. The EMP is a guiding document that will direct the College for the next 10 years. The group also reviewed and approved the Cyclic Review Process which identifies many College plans and the timeline for updating those plans.

The Finance Committee will meet for the first time this semester on December 11th.



Vice President's Report

One issue that is being focused on by the Academic Senate is the process for which grants are sought and eventually applied for. Specifically, the Senate will vote on the 2nd and final reading of *Resolution FA23-A: Shared Governance Participation in Grant Applications for Columbia College* at the next full Senate meeting.

If this resolution passes, Marcus will be directed to negotiate an MOU with Dr. Tran that establishes input and participation from the Senate when non—recurring grants are sought.



In anticipation of the resolution passing its 2nd reading, Marcus has asked me to start solicitating input from faculty as to what should be included in the MOU. Please email me your thoughts on this at <u>andale@yosemite.edu</u>

On the topic of *Shared v. Participatory Governance*, it was noted that the title of the FA23-A resolution should be amended to replace *shared* governance with *participatory* governance. This is a good suggestion, in my opinion. For those of us who served in Senate leadership positions long ago, we recall that shared governance was the term that was routinely used. Perhaps that was never a good term to use in the first place, as it implies that the Senate shares policy and procedure making decisions with the administration and YCCD Board. But as we know, our rights under AB 1725 are to "ensure faculty, staff, and students...the right to *participate* effectively in district and college governance" and, further, to ensure "the right of academic senates to assume primary responsibility for making recommendations in the areas of curriculum and academic standards."

As I shared in the first Academic Senate meeting on 8/24/23, each of the following resources are available for review from the <u>Curriculum Committee</u> <u>Webpage</u>.

We currently do not have a SLOPR Coordinator on the Curriculum Committee. I began discussions with the VPI to see how the duties for the job might be modified and shared those discussions with the full Academic Senate on 9/15/23. There seemed to be agreement in the Senate meeting that the PR piece of SLOPR be removed. A draft MOU will be presented to the College President by the Academic Senate President and Academic Senate Vice President for 40% faculty release time to support Student Learning Outcomes. Senate leadership will share the results with the full Senate.

2024-2025 Catalog Curriculum Submission Deadline: October 6, 2023 Curriculum changes for 24-25 catalog must be *submitted by* this date.

A Baccalaureate Degree proposal was submitted to the state on 9/5/23 for Cooperative Land Stewardship. This has prompted the Curriculum Committee to develop policy and procedure for upper division courses.

Legislative Changes Impacting Curriculum:

- AB 1111 Common Course Numbering (Fully implemented July 2024) Legislation requires all courses in our Cal/GETC and ADT's to be revised and approved using common course numbering. The ASCCC acknowledges that the timeline is not realistic, none the less, this is our charge.
- AB 928 Cal/GETC & ADT (Fully implemented Fall 2025)
- Title 5 changes to Work Experience Education Regulations Revisions **Summary of Regulatory Changes**
 - The work experience regulations replace the former "cooperative work experience" regulations that were first promulgated decades ago. The new regulations are organized into 5 principle sections: "Purpose and Definition of Work Experience Education" (section 55250), "District Responsibilities" (section 55251), "Work Experience Education Documentation" (section 55252), "College Credit, Attendance Accounting, Course Repetition" (section 55253), and "Records" (section 55254).

The Institutional Effectiveness Council (IEC) held the first meeting for fall semester on September 11th.

The agenda focused on discussing the data collected to measure the College's progress toward strategic plan goals. At fall in-service, a one-page strategic plan update was distributed. The IEC discussed additional data that would help illuminate progress toward those goals including rate statistics rather than just aggregate numbers. The committee also requested that Matt Connot (Research Analyst) add at least a few notes to describe the context for the data presented. The council discussed what kinds of data could be used to measure goals and opportunities to share the data with constituent groups. Matt identified the need to adjust the floor and target as we continue to make progress toward reaching the goals in the strategic plan.

Matt will be sharing the results of the Governance Survey at the next meeting.

The Council agreed to compile updates to the Participatory Governance Handbook throughout the year and then present them to College Council once a year.

The Council corrected the dates on the Strategic Plan and revised the name of the Diversity, Equity and Inclusion committee to Diversity, Equity, Inclusion, and Accessibility Committee in the Participatory Governance Handbook.

Distance Education Coordinator Report

The Distance Education Committee held its first meeting of the 2023-2024 school year on September 22nd. Our meeting dates for the year are as follows:

- October 20th

Below are highlights of what we discussed during this first meeting!

- Progress on the Online Student Handbook, Distance Education Handbook, and the Distance Education Plan. All of these need to be updated. We have a goal of getting these updated by the end of the academic year. We've created small teams of committee members to focus on each document.
- Update on Simple Syllabus: We are piloting the tool with "Sandbox Sessions" that faculty volunteered to participate in. Faculty join a Zoom meeting with the representative and remote control the screen to try out the tool, and there's time for Q & A.
- Idea of continuing something like 5 for \$500 and/or focusing efforts on Accessibility for professional development.
- Title V changes and potential impacts to Distance Education. I am coordinating with MJC to align expectations due to these changes.
- Faculty Website alternatives such as Google Sites and the opportunity for workshops on creating such sites.
- Locating/adding Syllabus Statements such as the DSPS Course Accessibility Statement directly to the Faculty Hub.
- New tools that faculty are interested in: Canva and VoiceThread. We are looking into the cost of Canva and funding options. We are considering a pilot of licensed VoiceThread.





Institutional Effectiveness Committee and Finance Committee



The Institutional Effectiveness Council (IEC) held the first meeting for fall semester on September 11th.

The agenda focused on discussing the data collected to measure the College's progress toward strategic plan goals. At fall in-service, a one-page strategic plan update was distributed. The IEC discussed additional data that would help illuminate progress toward those goals including rate statistics rather than just aggregate numbers. The committee also requested that Matt Connot (Research Analyst) add at least a few notes to describe the context for the data presented. The council discussed what kinds of data could be used to measure goals and opportunities to share the data with constituent groups. Matt identified the need to adjust the floor and target as we continue to make progress toward reaching the goals in the strategic plan.

Matt will be sharing the results of the Governance Survey at the next meeting.

The Council agreed to compile updates to the Participatory Governance Handbook throughout the year and then present them to College Council once a year.

The Council corrected the dates on the Strategic Plan and revised the name of the Diversity, Equity and Inclusion committee to Diversity, Equity, Inclusion, and Accessibility Committee in the Participatory Governance Handbook.

Distance Education Coordinator Report

The Distance Education Committee held its first meeting of the 2023-2024 school year on September 22nd. Our meeting dates for the year are as follows:

- October 20th

Below are highlights of what we discussed during this first meeting!

- Progress on the Online Student Handbook, Distance Education Handbook, and the Distance Education Plan. All of these need to be updated. We have a goal of getting these updated by the end of the academic year. We've created small teams of committee members to focus on each document.
- Update on Simple Syllabus: We are piloting the tool with "Sandbox Sessions" that faculty volunteered to participate in. Faculty join a Zoom meeting with the representative and remote control the screen to try out the tool, and there's time for Q & A.
- Idea of continuing something like 5 for \$500 and/or focusing efforts on Accessibility for professional development.
- Title V changes and potential impacts to Distance Education. I am coordinating with MJC to align expectations due to these changes.
- Faculty Website alternatives such as Google Sites and the opportunity for workshops on creating such sites.
- Locating/adding Syllabus Statements such as the DSPS Course Accessibility Statement directly to the Faculty Hub.
- New tools that faculty are interested in: Canva and VoiceThread. We are looking into the cost of Canva and funding options. We are considering a pilot of licensed VoiceThread.



Vice President's Report

The Brown Act - Spring, 2024 and Forward

At our last Senate meeting we discussed the Brown Act and the Senate's requirement to hold meetings in person, beginning January 1st. I've since had some questions from faculty concerning these 'new' rules. So, here's a recap:

The "Classic" (pre-Covid) Brown Act provision allowed for remote teleconferencing. And because the Classic Brown Act still applies, "A" member can join the meeting remotely so long as 1. That remote location is published in the agenda, 2. The remote location is open for the public to join the meeting, and 3. That member does not join remotely for more than 20% of the meetings in a calendar year.

The only real change, starting in January, is one additional option: if "A" member wants to join remotely and has a justifiable reason (caring for a family member, sick, traveling on district business, etc.), that remote location need not be published in the agenda and that location need not be open to the public. While the Senate meetings will need to be scheduled for in-person, faculty may remotely join those meetings for up to 20% of the calendar meetings.

<u>VPI</u>

Our VPI office has experienced some irregularities in terms of having a VPI. As we know, Brian Sanders is currently our (permanent) VPI. However, he was assigned as MJC's interim VPI and he remains in that position today. To fill his spot, Raelene stepped up as our interim VPI. But Raelene is currently on leave. Dr. Tran chose to fill the VPI vacancy by assigning those tasks to Melissa Raby, as an additional duty. But that doesn't seem like a prudent move, IMO. The VPI on any campus is arguably one of the most important positions. The VPI ensures compliance with many Title V mandates, oversees enrollment management, serves as the district officer for our curriculum issues, and many more very vital tasks. VPI duties can't be effectively accomplished as additional duties.

Brian Sanders is a finalist for the president position at Woodland Community College and also MJC. If he becomes a president at one of those colleges, or does not get one of those positions and decides not to return to Columbia College, we need to work with administration to get the search going for a permanent VPI quickly!

Curriculum Chair Report

The Curriculum Committee continues to move forward with implementation and operationalization of multiple legislative modifications to California Educational Code. A big thanks to all the members of the Committee for their commitment to the well-being of the college's curriculum.

> The Academic Senate approved the Columbia College Philosophy and Criteria for Associate in Science and Associate in Arts Degrees and General Education at the November 17, 2023 Academic Senate meeting.
> o Area E will no longer be a part of CCGE



- In addition, our Noncredit Coursework and Certificates of Competency and Completion Requirements for the 2024-2025 Catalog were approved.
- Columbia College's guiding principles for Activity Units were also approved. Activity units at Columbia will be referred to as "Lab with Homework (Activity) Units".
- New courses were assigned to appropriate disciplines in the following areas: Ethnic Studies, Music, Geography and Guidance.
- Columbia's Baccalaureate Degree Proposal in Cooperative Land Stewardship was denied approval by the CCC Chancellors Office on 10/13/23 however, administration plans to resubmit in January.
- In Spring 2024 the Curriculum Committee will be reviewing curriculum developed by MJC faculty working on stipends resulting from a grant award related to Health Career Education. Administration informs us that we will be offering a Certified Nursing Assistant (CNA) Skills Attainment Certificate as well as a Medical Assistant (MA) Certificate of Achievement. Columbia College does not currently employ any qualified discipline faculty in Medical or Health Career Education which is why MJC faculty will develop the curriculum. Administration is going after grants in areas that we do not have fulltime faculty. Full-time faculty were not requested in the College Outlook.
- The Academic Senate approved waiving the Academic Senate bylaws to include all full-time faculty members as eligible to serve as Curriculum Chair for the 2024-2025 academic year.
- SLOPR Coordinator position on Curriculum Committee updated to SLO Coordinator to reflect changes to the SLO MOU .
- Title 5 (55250 et seq) has been updated with regards to Work Experience. This will require modification on all Work Experience classes in all disciplines. The Curriculum Committee is seeking to coordinate with administration on the appropriate course of action for these modifications and alignment with board policy.

Technology Committee

The Technology Committee met on November 16.

- Some Committee members have shifted since the last meeting in the spring; consequently, all participants were introduced. Brook Crouse, Executive Secretary of Student Services conducted the meeting.
- Jeff Swank reported on the issues with the Oak Pavilion sound system which was installed incorrectly, and now is being assessed and problem solved.
- Martin Kjaer led a discussion about charging students for nonreturn of laptops. Suggested fees would be \$150 for old laptops, \$450 for new ones, and an undisclosed amount for the high-end laptops.
- Martin encouraged anyone interested in replacing old computers for their department, to get a quote from our IT. Current money for replacement of computers will not be like it was during Covid. Purchasing computers will be a department-by-department decision pending available funding.
- Ryan Brady announced that New Firewalls have been installed across the District providing greater protection for the network. Eventually Columbia sill be getting new desk phones.
- A discussion about MFA (multifactor authentication) took place. All colleges that receive federal money, (like Pell Grants) are required to implement MFAs. There is currently the ability to sign up for MFA via the IT Service Portal for those who wish to participate in a soft roll out.
- Joe Macklin announced that they are now working on the CVC-OEI (California Virtual College-Online Educational Initiative) which will allow Columbia College to become a teaching college for Distance Education. That could occur sometime in the spring semester.



Vice President's Report

FHP Process

At the time of this writing we look forward to our FHP meeting on Friday, October 27th. We have all been asked to complete a survey that addresses each proposal, which will be compiled as a resource for this meeting. And at this meeting, we will build consensus as to the rankings of each proposal.

Then, a combined faculty-administration FHP committee will meet to finalize the rankings of the FHP proposals. *Note: the faculty consensus on the ranking may change, based on the discussions during this meeting.* Those rankings will then go to Dr. Tran, for her final determination on which faculty positions are to be filled.

Each year the district authorizes new and replacement positions that Columbia College can fill. Some years we are authorized no new faculty positions. It seems that an average of two or so positions are authorized. However, we've seen many more faculty positions authorized in recent years. Marcus and I met with Dr. Tran on Tuesday, October 24th and she confirmed that the district has not yet authorized new faculty positions. While I have not been involved in Senate leadership for a while, I don't believe that it is unusual for us not to have faculty positions authorized this early in the year. The district uses many metrics to make decisions on new and replacement faculty positions. And so FTES, retirements, and other data for this year may be needed to inform the district their authorizing faculty hiring. From my memory, it seems that late the fall, or early in the spring semester is a more common timeframe for the district to announce new faculty positions.

<u>50% Law</u>

As an FYI, the 50% Law refers to the requirement that all k-12 and community college districts must spend at least 50% of their budget for instruction. And specifically, *direct* instruction. What this boils down to is classroom teachers and classified staff positions that support that direct instruction. So, for examples, positions such as a counselor, administrator, or admissions and records specialist would not be considered direct instruction. The 50% Law is one of many considerations that the district uses to determine new or replacement faculty hiring.

Hello curriculum friends!

The Curriculum Committee has been busy! In addition to reviewing over 100 courses and their DE/CE Addenda and almost 25 awards this fall (roughly ¼ of our curriculum), the Committee has the following news:

1. SLO Coordinator MOU: An MOU has been developed to separate Program Review from Student Learning Outcomes coordination. The Academic Senate is seeking a



- 2. In preparation for the implementation of Curriculum-Related Initiatives the Curriculum Committee Chair, Curriculum Specialist and the Articulation Officer, began a discussion with acting VPI Melissa Raby to review the following Curriculum Related Initiatives:
 - Resolution Number 04.02 CalGETC AB 1460, AB 928, AB 1111
 - and AB 927
- Standards, Policies & Procedures for Intersegmental General Education Transfer Curriculum Version 2.3

These initiatives will require extensive planning and human resources to fully implement. The acting VPI agreed that we should begin planning for our Articulation officer to receive 100% release time beginning Spring 2024. As a point of clarification, Melissa Raby did not think we needed to take this through the Academic Senate as a resolution or MOU. She indicated that she would follow up as soon as possible to codify this plan. After sharing this information with Academic Senate leadership, it was decided that we would prepare a Resolution to codify the plan. You should expect to see a first reading at the November Academic Senate meeting.

3. Elections Curriculum Chair- Columbia College will need to secure a new Curriculum Chair for 2024-2026 academic years. Institutional Effectiveness Committee (IEC)

The IEC met on 11/6 and discussed the results of the Governance Survey, the Educational Master Plan (EMP), and the Cyclic Review Process. Matt shared the participation on the governance survey was lower than the previous year and the group discussed how to increase participation in the future. The survey included three new questions. Matt will share the qualitative responses collected on the survey at a future IEC meeting.

The group approved the second reading of the EMP and sent it on its way to College Council. The EMP is a guiding document that will direct the College for the next 10 years. The group also reviewed and approved the Cyclic Review Process which identifies many College plans and the timeline for updating those plans.

Adrienne is a tri-chair for the IEC this year and Jim Retemeyer and Kirsten Miller are also serving. We are need of one additional faculty member. The IEC meets in the afternoon of the first Monday of the month.

The Finance Committee will meet for the first time this semester on December 11th.
