Re: Notification of Distance Education Programs, Fall 2020

Effective Summer 2020, all programs of study at Columbia College are now eligible to be taught via distance education. The Columbia College Curriculum Committee convened this summer to conduct a thorough review of every course in our curriculum and designated each with all appropriate distance education modalities. The committee determined the appropriateness of each of the following modalities for each course in its catalog:

- Fully Online
- Fully Online but only upon mutual agreement between the Academic Senate and Administration (generally intended for emergency use only)
- Online with Flexible In Person Components (e.g. online with a few occasional face-to-face meetings for skill development, field trips, laboratories, or assessments)
- Partially Online with some components online and others face-to-face
- Correspondence Education to be utilized for student-inmates at prisons and jails

All lecture courses were approved to be offered fully online. Lecture-lab and lab-only courses were approved to be offered in manners appropriate to the discipline and course of study. As a result of this extensive review, at least 50% of every program of study at Columbia College can now, hypothetically, be offered online. With the shift to online instruction due to the COVID-19 crisis, students are now pursuing all of these programs of study via online and hybrid course offerings.

As previously reviewed by the Commission as part of our Substantive Change proposals and full accreditation site visits, Columbia College offers a comprehensive slate of student services to fully support online learners. All face-to-face services are available and well utilized in the online environment.

The College is accurately communicating to its students about the status and quality of these online and hybrid course offerings. Fall registration is strong in spite of the ongoing COVID-19 crisis. The College has provided thorough training in online instructional methodologies and strategies for many years. The College is a leader in online instruction, serving as a member of the Online Education Initiative since its inception.

In spring and summer of 2020, thorough faculty training opportunities have been offered to all untrained faculty members to prepare for fall. Moreover, seasoned online instructors have participated in extensive skills-upgrade training to further improve their effectiveness. Finally, any instructor who has not yet been fully certified to teach online will be enrolled in a concurrent training program in the fall 2020 semester. This training program will ensure that their online course offerings meet the expectations of quality established by the College, consistent with the ACCJC Standards, with special emphasis on regular and substantive interaction between the students and the instructor, as expected by the ACCJC Policy on Distance Education and on Correspondence Education.

The programs of study listed in the following pages will all be offered via Distance Education to some level effective summer 2020 and thereafter. If you have any questions or concerns, please do not hesitate to contact me.
