G. Mascot Idea Submission Form

Professor White discusses with basic stuff to talk about Mascot Selection Process and Land Acknowledgement presentation and creating mascot idea submission form for staff members and students.

Need a set of documents to create a criteria to identify and evaluate the mascot. To get a criteria established and get teams' documents to add and subtract to develop a submission from online.

That submission form goes out for the second week in Spring Semester to have the ability to have mascot ideas to change it.

Go over the rubric and criteria that discuss the mascot due to its original background in a friendly way as part of the guidelines before making a final decision to take place in April, 2026.

Before graduation, the final decision of the mascot idea is announced for students and staff members.

During summer, staff members and faculty team discusses the ideas for the graffiti artist to create a new mascot for our campus.

Don't name the mascot after famous people based on politics and religion, to avoid the profession based on indigenous background.

When you submit the idea for the mascot to represent the college campus in a positive way to sketch an idea for the faculty team.

Ask for clarification to have multiple meanings, and to look up the definitions to give the community as much information as needed for the rubric to send out to the student government.

The next steps are to get your approval on this process from the Student Body by December 9th.

To have sent links to the college campus community in mid-January, 2026 and wait for further instructions.

To have submission reviews for the work group members to evaluate the mascot ideas to submit individuality on time.

TO have ranked choice voting and making final selections from faculty members.

To have land acknowledgment for respecting the indigenous peoples of the "Southern-Central" Sierra Miu Wuk.
