

Columbia College Financial Aid Office Terms of Agreement

By accepting an offer of financial aid, you acknowledge responsibility for understanding and complying with these TERMS OF AGREEMENT. This official agreement between you and the Financial Aid Office is enforced throughout the length of the award. The Terms of Agreement are subject to amendment without notice because of frequent changes in the laws, rules, and regulations that govern financial aid. The following Terms of Agreement apply to all financial aid programs.

AVAILABILITY OF FUNDS - All financial aid awards offered by Columbia College are limited to the availability of funds. In the event that the state or federal government reduces or eliminates funds, the Columbia College Financial Aid Office may reduce and/or cancel your award.

ACADEMIC QUALIFICATIONS - To be eligible to receive Financial Aid funds, you cannot be concurrently enrolled in highschool and must have earned a high school diploma, GED, or equivalent. You also must be enrolled in a payable program, current payable programs can be found here http://www.gocolumbia.edu/financial aid/PayableDegrees.pdf.

CHANGE IN ENROLLMENT/ATTENDANCE STATUS, WITHDRAWAL, AND LEAVE OF ABSENCE - Our offer of financial aid is contingent upon your admission, enrollment, and attendance at Columbia College. You must be enrolled for the purpose of obtaining a payable degree or certificate, or you must be enrolled in a transfer program leading to a bachelor's degree. Minimum enrollment for all programs <u>except</u> Federal Pell Grant is six units. For students meeting specific eligibility requirements, Federal Pell Grant is available at less than half time. **Your award offer is based on full-time enrollment and is subject to change if your unit load is less than full-time.** The Federal Pell and Cal Grants are disbursed according to your unitload as follows:

*Cal Grant not available at less than half time. Cal Grant C recipients must be enrolled in a technical/vocational course of study. Students on a wait list who have not registered for all courses prior to a disbursement date could have their funds delayed or amount reduced. A change in enrollment/attendance status during a semester could change or cancel your award. It is the student's responsibility to complete the withdrawal process with the Admissions and Records Office. Should you withdraw or take a leave of absence, your remaining financial aid award for the current semester will be canceled. If you drop prior to attending a class you will be considered a 'No Show' and will be required to repay all of the funds back.

USE OF FINANCIAL AID FUNDS - You must use your financial aid funds only for expenses that are directly related to your cost of education (tuition and fees, books and supplies, room and board, transportation, personal expenses, and school-related dependent care expenses).

DISBURSEMENT OF FINANCIAL AID FUNDS (REFUND) - Financial aid funds are typically disbursed in two installments during the Fall and Spring semesters. Summer semester disbursements will depend upon the start date of course(s)as we fund Summer classes the disbursement date that follows the start date of the class. Your disbursement schedule may varydepending on your application date, the types of aid you are awarded, and course start dates – financial aid cannot be disbursedfor late start classes until after the class begins. Financial Aid disbursements are paid to students' BankMobile accounts. All disbursement dates are listed on your award letter and on the Columbia College Financial Aid Office website.

YEAR-ROUND PELL GRANT – The U.S. Department of Education has implemented Year-Round Pell Grants allowing student to receive up to 150% of a regular grant award over the course of the academic year (Fall, Spring, Summer). Students who attend full-time for Fall and Spring semesters may be eligible to receive Pell Grant funding during the Summer Semester ifthey meet all Pell grant eligibility requirements and are enrolled in at least half-time. All Pell Grant disbursements will be included in the student's 600% maximum Pell Lifetime Eligibility Used (LEU).

FREEZE DATES – Freeze dates are the dates that the Financial Aid Office will freeze and record your unit load to determine your total unit load for the semester. Classes added or dropped after the semester's freeze date will not be counted toward future

financial aid disbursements. However, if you never attended a class or your class was cancelled after the freeze date you will incur a financial aid overpayment. Freeze dates will be posted on each semester's list of disbursement dates and on the Dates and Deadlines section of the Financial Aid website.

RETAKING COURSEWORK – A student may be paid one time for a previously passed course. For this purpose, passed means any grade higher than an "F." In other words, the student may be awarded Title IV aid for a second term only, regardlessof the grade earned on the repeated course.

ENROLLMENT AT MORE THAN ONE INSTITUTION - Federal law states that a student may not receive financial aidfrom two separate institutions at the same time. A student attending more than one college during the same semester should apply for financial aid at the school in which they are enrolled in the greater number of units. Students in this situation may qualify for a Consortium Agreement, which allow the disbursing college to consider units of attendance at another institution. Contact the Financial Aid Office for additional information.

DEDUCTION OF OBLIGATIONS - Obligations owed to Columbia College or Modesto Junior College may be deducted from your financial aid disbursements. Obligations will not be deducted from Federal Work-Study earnings.

ADDING/DROPPING – Adding and dropping units can cause a change in the amount of the award you receive. Dropping units during the semester or dropping all courses will cause the financial aid award to be recalculated. A semester award may be reduced and a repayment may be required. Dropping to less than half time will require you owe back all or part of your first disbursement. If you drop all units before 60% of the semester is completed, you may owe a repayment of your Federal Pell award according to the Return of Title IV Funds Regulation.

RETURN OF Title IV FUNDS REGULATION

Overpayments (mid-point Recalculation) – If a student received Pell grant for 6 or more units before the mid-point of the term and then drops units resulting in a less than half time enrollment status before the semester is halfway over, the student will owe grant funds back. This would happen when a student had been issued a payment for half of the term award and the amount disbursed for that enrollment status was greater than the new eligible amount for the entire term award. The Financial Aid Office will calculate if an overpayment occurs and notify the student with the dollar amount, due date, and procedures.

Return to Title IV Funds (R2T4) – A student who receives federal financial assistance and withdraws from all of their classesbefore completing more than 60% of the semester will be required to return any unearned federal funds. The amount of the return will be calculated on a pro-rata basis. The percentage of Title IV funds earned will be calculated by the Financial Aid Office and if there is an unearned amount that was disbursed (overpayment) or if there is an earned amount not disbursed (Post-Withdrawal Disbursement 'PWD'), the student will be notified of the dollar amount, due date, and procedures.

No Show Overpayments – Students who do not begin attendance are 'No Show' and are not considered R2T4. A student is not eligible for financial aid for any classes in which they were 'No Show.' If any funds were disbursed for 'No Show' classes, the resulting overpayment will be due immediately and charged to the student's account. The student will be notified of the dollar amount, due date, and procedures.

REFUNDS / PAYMENTS / DISBURSEMENTS – All financial aid disbursements are sent to students' BankMobile accounts. Students must activate their BankMobile account and choose a preference of how refunds are to be disbursed. Disbursement options include: 1. Vibe Account (directly deposited to BankMobile Vibe card) or 2. ACH transfer (directly deposited to student's own personal checking or savings account).

Refund dates are listed on the Financial Aid web page under Dates and Deadline. If a student has dropped units or is not attending and received financial aid, the student will be subject to repayment of financial aid funds. Any funds not repaid willbe reported to Department of Education.

RETURN OF Title IV FUNDS REGULATION-CONTINUED

If a determination is made that the student received more than the earned amount, the unearned portion will be returned by the college (Institutional Share), by regulations, within 45 days of the 'Withdrawal Date Determination' and/or by the student in accordance with the methods prescribed in the regulations. The institutional charges for the semester will be multiplied by the percentage of the Title IV aid unearned and compared to the amount of the title IV aid to be returned. The smallest amount will be returned by the college in the following priority:

- 1. Unsubsidized Loans
- 2. Subsidized Loans
- 3. Federal Direct Loans
- 4. Federal PELL Grants
- 5. Iraq and Afghanistan Services Grants
- 6. Federal Supplemental Opportunity Grant (FSEOG)
- 7. Teach Grants

EDUCATIONAL PLAN - Students are required to have a Student Educational Plan (SEP) on file with the Counseling Officeand/or Financial Aid Office prior to completing your first semester.

SATISFACTORY ACADEMIC PROGRESS – To be eligible to receive financial aid funding a student must meet and maintain Satisfactory Academic Progress (SAP). AMENDED DISBURSEMENTS / OVERAWARDS - Students receiving funds based on false information and/or any funds received in excess of the amount of which the student is entitled will be subject to repayment regardless of any reason.
